## OPERATIONAL INSTRUCTION ISSUED BY THE STATE BOARD OF FINANCIAL INSTITUTIONS APRIL 4, 2007

Unless otherwise instructed by the State Board of Financial Institutions (Board) or the Commissioner of Banking, State chartered banks may, without the specific approval of the Board, engage in investment activities as national banks are permitted to do.
